Scholarships/Awards - During fiscal year 2017-18, we awarded 35 college scholarships to recent Lowell graduates (\$100,094), most of which are funded by perpetual endowed scholarship funds. We also awarded 22 academic prizes/awards (\$35,950) to current students, recognizing outstanding achievement in English, Mathematics and Science.

4b (Code:) (Expenses \$ 118,579. including grants of \$) (Revenue \$ 85,434.)

Alumni Programs/Services - The Lowell Alumni Association provides a free semi-annual alumni newsletter that is mailed to more than 33,000 alumni, former faculty and other friends of Lowell High School (\$17,895). We also support and facilitate regular class reunions (\$83,094, funded primarily through ticket sales but including \$4,765 of direct LAA support) and alumni participation in the school's annual commencement exercises (\$2,705). The LAA Executive Director also engages in various Alumni Relations activities (\$14,885).

4c (Code:) (Expenses \$ 88,771. including grants of \$ 88,771.) (Revenue \$)

Grants Program - Twice each year, we solicit requests from Lowell faculty, staff and coaches. Our Grant Committee evaluates the requests and makes funding recommendations to the LAA Board of Directors. Major grants funded during fiscal year 2017-18 include support for the Lowell Robotics team (\$37,109) and Speech/Debate team (\$9,001); support for the Lowell Advanced Placement exam program (\$22,440, including \$16,996 to provide exam fee subsidies for students with financial need); purchase of a new boat for the Dragon Boat team (\$5,400); new uniforms for the soccer (\$3,600) and basketball teams (\$2,177); and funding for student travel (with an emphasis on assisting students with financial need) by the choir (\$4,300) and baseball team (\$2,500).

Other than the election of directors, the only other action that requires a vote of the membership, pursuant to the bylaws, is an amendment to the bylaws regarding the authorized number of directors. The Board of Directors is explicitly authorized by the bylaws to carry out all other operations of the organization.

Local chapters abide by the same policies and procedures as Lowell Alumni Association.

Review and analysis by Executive Committee, followed by proposal to full Board of Directors for consideration.
