Scholarships/Awards - During fiscal year 2018-19, we awarded 90 college scholarships to recent Lowell graduates (\$185,267), most of which are funded by perpetual endowed scholarship funds. We also awarded 16 academic prizes/awards/stipends (\$27,400) to current students, recognizing outstanding achievement in English, Mathematics and Science.

Alumni Programs/Services - The Lowell Alumni Association provides a free semi-annual alumni newsletter that is mailed to more than 33,000 alumni, former faculty and other friends of Lowell High School (\$57,478). We also support and facilitate regular class reunions (\$106,955, funded primarily through ticket sales but including \$4,014 of direct LAA support) and alumni participation in the school's annual commencement exercises (\$4,019). The LAA Executive Director also engages in various Alumni Relations activities (\$17,783).

Grants Program - Twice each year, we solicit requests from Lowell faculty, staff and coaches. Our Grant Committee evaluates the requests and makes funding recommendations to the LAA Board of Directors. Major grants funded during fiscal year 2018-19 include support for the Lowell Robotics team (\$23,620), Speech/Debate team (\$11,609) and Model United Nations program (\$2,500); funding for student travel (with an emphasis on assisting students with financial need) by the Lowell Choir (\$6,437 for their trip to Seattle), Lowell Orchestra (\$4,992 for their trip to Southern California) and Lowell geology class (\$4,958 for their trip to Yosemite); sponsorship of the California Poets in the Schools program (\$5,000); support for the Lowell Black Student Union (\$2,025) and JROTC program (\$2,800); and purchase of theater tickets for Lowell drama students (\$3,630).
